STEPHEN J. BLANK has been Research Professor of National Security Affairs at the Strategic Studies Institute of the U.S. Army War College since 1989. Prior to this appointment, Dr. Blank was Associate Professor for Soviet Studies at the Center for Aerospace Doctrine, Research, and Education of Air University at Maxwell AFB. He earned his M.A. and Ph.D. in Russian history from the University of Chicago. Dr. Blank has published over 170 articles on Soviet/Russian military and foreign policies. His most recent book is *Imperial Decline: Russia's Changing Role in Asia* (1997), which he coedited with Professor Alvin Rubinstein of the University of Pennsylvania. Dr. Blank is also the author of a study on the Soviet Commissariat of Nationalities, *The Sorcerer as Apprentice: Stalin's Commissariat of Nationalities* (1994), and coeditor of *The Soviet Military and the Future* (1992).

THOMAS B. COCHRAN is Senior Scientist with the Natural Resource Defense Counsel (NRDC), and Director of the NRDC's Nuclear Program. He initiated NRDC's Nuclear Weapons Databook Project and a series of joint nuclear weapons verification projects with the Soviet Academy of Sciences, including the Nuclear Test Ban Verification Project and the Black Sea Experiment. Dr. Cochran wrote *The Liquid Metal Fast Breeder Reactor: An Environmental and Economic Critique* (1974), and was coeditor/author of the *Nuclear Weapons Databook, Volume I: U.S. Nuclear Forces and Capabilities* (1984); *Volume II: U.S. Nuclear Warhead Production* (1987); *Volume III: U.S. Nuclear Warhead Facility Profiles* (1987); *Volume IV: Soviet Nuclear Weapons* (1989); and *Making the Russian Bomb: From Stalin to Yeltsin* (1995). He has also published numerous articles and working papers, including those in SIPRI Yearbook chapters, *Arms Control Today*, and *The Bulletin of the Atomic Scientists*. He was Assistant

Professor of Physics at the Naval Postgraduate School from 1967 to 1969, Modeling and Simulation Group Supervisor of the Litton Mellonics Division, Scientific Support Laboratory, from 1969 to 1971, and Senior Research Associate at Resources for the Future from 1971 to 1973. Dr. Cochran received his Ph.D. in physics from Vanderbilt University.

ARIEL COHEN is a well-known area expert on Russia, the New Independent States (NIS), and Central and Eastern Europe. He is currently the Research Fellow in Russian and Eurasian Studies at the Heritage Foundation and manages a policy research program on Russia, NIS, and Central Europe. Dr. Cohen has expertise on energy politics in the Middle East and the Caspian Sea region, rule of law, legal reform, international organized crime and corruption, democracy development, and public diplomacy. He frequently testifies before Congressional committees and appears regularly on CNN, NBC, Fox, and BBC-TV. He serves as a commentator for United Press International and Voice of America weekly TV and radio shows, and writes as a guest columnist for the *Washington Post*, *USA Today*, *Wall Street Journal*, *Journal of Commerce*, *Investor's Business Daily*, and *Washington Times*. Dr. Cohen authored *Russian Imperialism: Development and Crisis* (1996). He has served as an adjunct faculty member at Georgetown University and at several West Coast universities.

MURRAY FESHBACH is a Research Professor of Demography and a faculty member of Georgetown University's Center for Russian, Eurasian, and East European Studies Program (CEREES). He is author of *Ecocide in the USSR* and *Ecological Disaster* and the editor-in-chief of *The Environmental and Health Atlas of Russia*. Dr. Feshbach served as Chief of the USSR Population, Employment, and Research and Development Branch of the Foreign Demographic Analysis Division (now the Center for International Research) of the U.S. Bureau of the Census. He was a Fellow at the Kennan Institute of the Woodrow Wilson International Center for Scholars. In

addition, upon the State Department's request he served as the first Sovietologist-in-Residence in the Office of the Secretary General of NATO, Lord Carrington, in Brussels, Belgium, from 1986 to 1987. Dr. Feshbach received his A.B. in history from Syracuse University, an M.A. in history from Columbia University, and a Ph.D. in economics from American University.

MARK KRAMER is the Director of the Harvard Project on Cold War Studies and a Senior Associate at the Davis Center for Russian Studies at Harvard University. He has taught at Harvard, Yale, and Brown Universities and was formerly an Academy Scholar in Harvard's Academy of International and Area Studies and a Rhodes Scholar at Oxford University. He has worked extensively in newly opened archives in Russia, Germany, Poland, the Czech Republic, Slovakia, Hungary, Bulgaria, Ukraine, Lithuania, Latvia, and several Western countries. He wrote *Crisis in Czechoslovakia, 1968: The Prague Spring and the Soviet Invasion* and is completing books titled *From Dominance to Hegemony to Collapse: Soviet Policy in East-Central Europe, 1945-1991* and *Soldier and State in Poland: Civil-Military Relations and Institutional Change After Communism*. He also has edited *The Collapse of the Soviet Union* and was the American editor and translator of *The Black Book of Communism*. He has written more than 100 articles on a variety of issues, including the Soviet and post-Soviet armed forces, the structures of Soviet and post-Soviet foreign policymaking, nuclear proliferation, post-Communist economic reform in East-Central Europe, social policy in East-Central Europe, civil-military relations in East-Central Europe, and the global arms trade.

MATTHEW A. PARTAN is a Senior Research Analyst at CENTRA Technology, Inc., with over 15 years of experience as a specialist in Russian studies, nonproliferation, and national security policy analysis. Dr. Partan manages CENTRA's ongoing work addressing threats posed by the potential smuggling of nuclear weapons or materials from the former Soviet Union. He oversaw CENTRA's

cooperative research program with Russian scientists that was conducted under the auspices of the Department of Energy Initiatives for Proliferation Prevention (IPP)/United States Industry Coalition (USIC) program. Dr. Partan has written company reports assessing issues related to the proliferation of advanced conventional weapons from Russia and other former Soviet states, regional security dynamics in Eurasia, and the status of Russian defense industry, and has published materials on issues related to military reform, industry, and strategy in the former Soviet Union. Prior to joining CENTRA, he was a John M. Olin Fellow at the Center for International Affairs, Harvard University, and a Research Assistant at the MIT Defense and Arms Control Program. Dr. Partan has a Ph.D. in political science from MIT and a B.S. in physics from Harvard University.

THOMAS RIISAGER is the Albert Wohlstetter Fellow of Russian Studies at the Nonproliferation Policy Education Center. Before joining NPEC, Mr. Riisager worked for Michael Page International, an accountancy recruitment firm based in London, as a consultant to multinational corporations and Russian businesses operating in the former Soviet Union. He served in the U.S. Army Military Intelligence Corps as a Soviet order of battle specialist and has interpreted for joint U.S.–Russian military activities and translated documents from Russian and German across a wide variety of topics for a number of public companies and institutions, including the World Health Organization. Mr. Riisager obtained his master's degree in Interpreting and Translating (Russian and German) from the University of Bath (UK) in 1998, and is a graduate of the United States Military Intelligence School and the Defense Language Institute.

HENRY D. SOKOLSKI is Executive Director of the Nonproliferation Policy Education Center and teaches graduate courses on proliferation at Boston University's Institute of World Politics. From 1989 to 1993, he served as Deputy for Nonproliferation Policy in the Defense

Department and in the Secretary of Defense's Office of Net Assessment. Prior to this, Mr. Sokolski served as senior military legislative aide to Senator Dan Quayle and as energy and nuclear legislative aide to Senator Gordon Humphrey. He was a proliferation consultant to the National Intelligence Council and served as a member of the Central Intelligence Agency's Senior Advisory Board and on the congressionally-mandated Commission to Assess the Organization of the Federal Government to Combat Proliferation of Weapons of Mass Destruction.
